Bob Kelly 20 plus year resident of the community he wanted to congratulate the council about how they have handled the money/overpayment and that they have not pointed any fingers.

iii. Take Public Comment on Ordinance 2022-12: An Ordinance Forgiving Overpayment of Compensation to Virgin's Elected and Appointed Officers for the 4-Year Period from July 2018 to June 2022 Due to Failure to Amend Compensation by Ordinance and Hold A Properly Notice Public Hearing.

Pat Galvez Stated that Virgin did not comply with the two Utah codes and one Virgin code. They are laws and they should have been followed. These laws where not followed, we should find another outcome than forgiving and should have a third party look at this. This current ordinance should uphold the laws like the council stated that during the memorandum because the law is the law due to a technicality. But stood by that because it is the law. He stated that you were sworn to uphold the law. Complete forgiveness is not ok and that is not the law. Your decision here is important and should uphold the law, the prior Town Council did not uphold the law. Will you be consistent, or will you be inconsistent with following the law? Jean Krause read a letter

I was extremely disappointed in our Town after hearing about the salary increases in the past 4 years. But even more disappointed that the ones who voted in the illegal changes are not stepping up to the plate and voluntarily returning the funds. The money came from taxpayers and is not theirs if it was done incorrectly. The percentage increases were astronomical and unheard of. And I don't believe they should be the ones to vote on the outcome. During the Spendlove regime the town grew suspicious of a lot of activities involving the town council and planning and zoning committee. I can only guess that this is not the only item that will be uncovered. I'm suggesting that specifically the ones who voted in the change, return the funds voluntarily, as no one wants to sue or be sued (as referenced in the newspaper article) OR going forward they do not take a salary. These folks should have the integrity to figure out what's the right option for the taxpayers. Best regards, Charles and Cheryl Sliger

Bob Kelly stated that he has heard about this for two weeks, and he feels that its slanderous. The article from the Tribune and stated it was wrong. Adele Pincock stated that she wanted to thank her former residents for speaking up. Does this have to be all or nothing? I get that it's a tricky situation. Is the Clerk included in this? We should consider a penalty if the rules are not followed in the future. It does matter 78,000 is a lot of money. I would like to know if the current salary form is available to the public. We should have the dates on when the ordinances changed.

Kent Peterson stated that he thinks the council should have a third party look at it.

Sean Amodt stated that this was addressed many times during the public meetings and talked about during the budget meetings. He stated that he is fine with putting it at zero for everyone.
